### **\$100 Room Deposit**

When you leave your dorm room for the season, take the copy of this application provided to you, to the Security Supervisor at the stable gate. Security will perform an inspection, sign the "Room Inspected by" section, and note any charges below.

After the inspection, present your copy of this application to the Security Office inside the facility. The Security Supervisor will return your deposit, minus any amount noted for damages.

You must also return the dorm room key. Failure to return the key will result in a \$25 charge against your deposit.

## Finger Lakes Gaming & Racetrack -Dormitories – 2021 Rules and Regulations

- **I will follow all FLGR policies, NYGC rules and all NYS COVID-19 public health mandates guidelines while I am on the property. And I understand and agree that ANY failure to follow them will be cause for my immediate removal from the property.**
- Each applicant must fully complete a dorm application, abide by all rules and be actively employed full time by a recognized FLGR trainer to be considered.
- Each dorm occupant's employer will be expected to cosign the dorm agreement.
- If dorm occupant is no longer working for the trainer, the dorm occupant will agree to vacate the room within 72 hours. If they subsequently secure employment with another trainer, they will have to complete a new application
- **A dorm room can only be occupied by its assigned individual. No other individuals are permitted in the rooms at any time due to social distancing restrictions. No visitation is allowed**
- Only authorized essential backside grooms who demonstrate an appropriate need will be granted a dorm room.
- **Backside dormitory and living areas will be monitored routinely for compliance by security team members. Security has the right to inspect dorm rooms at any time.**
- **All dorm inhabitants will make themselves available at a pre-determined time for a daily wellness check by FLGR personnel as per NYGC mandate.**
- Dormitory assignments and any changes will be made by Backside Security Supervisor.
- Trainers will be held responsible for keeping their employee badge list up to date per order of the State Steward.
- Dormitory occupants are restricted to those persons who require overnight sleeping quarters.
- No one under 18 years old shall be assigned a dorm room.
- Occupants are required to keep their living quarters clean
- Occupant of their room and their trainers will be held accountable for any damage to the room.
- **Alterations or repairs to dorm rooms are prohibited unless approved by the Association.**
- Unauthorized locks shall not be placed on dorm room doors.
- Dorm room keys shall not be duplicated or exchanged.
- Heaters and cooking units are prohibited.
- Pets are prohibited.
- When dorm rooms are vacated, all personal belongings shall be removed and keys returned to security. Any items left behind will be disposed of by FLRA.
- Absolutely no extension cords, power strips, three way splitters, etc.
- A max of 6 items plugged in at one time.
- A Reading lamp of not more than 100 watts allowed.
- A small apartment sized refrigerator up to 3 cubic feet and less than 10 years old is allowed.
- **Air conditioner no larger than 5900 btu, no older than 5 years old. Must be installed by maintenance and maintained and cleaned by occupant.**
- All electrical equipment deemed unsafe or inefficient by FLRA's electrician or management must be removed immediately from the premises.
- **Note – The Finger Lakes Racing Association, may, at its discretion, and without prior notice, cancel the dorm room privileges of any individual for violation of the above regulations, or any other cause deemed to be in its best interest.**

## **Dormitorios – Reglas y Reglamentos**

- Las asignaciones de dormitorios y cualquier cambio serán realizados por el Supervisor de Seguridad de Backside.
- Los Entrenadores serán responsables de mantener su lista de insignias de empleados actualizada por orden del Administrador Estatal.
- Los ocupantes de las habitaciones compartidas están restringidos a aquellas personas que requieran dormir durante la noche.
  
- A nadie menor de 18 años se le asignará un dormitorio.
- Los ocupantes deben mantener sus viviendas limpias
- El ocupante de su habitación y sus entrenadores serán responsables de cualquier daño a la habitación.
- Las modificaciones o reparaciones en los dormitorios están prohibidas a menos que la Asociación lo apruebe.
- Las cerraduras no autorizadas no se colocarán en las puertas de las habitaciones compartidas.
- Las llaves de la habitación compartida no deben estar duplicadas ni intercambiadas.
- Los calentadores y las unidades de cocina están prohibidos.
- Las mascotas están prohibidas.
- Cuando se desalojen las habitaciones compartidas, se retirarán todas las pertenencias personales y se devolverán las llaves a la seguridad. FLRA eliminará todos los artículos que queden atrás.
- Absolutamente sin cables de extensión, tiras de alimentación, divisores de tres vías, etc.
- Un máximo de 6 elementos enchufados a la vez.
- Se permite una lámpara de lectura de no más de 100 vatios.
- Se permite un pequeño refrigerador de tamaño de apartamento de no más de tres pies cúbicos y no más de diez años de edad.
- Aire acondicionado no mayor de 5900 btu, no mayor de 5 años de edad. Debe ser instalado por mantenimiento y mantenido y limpiado por el ocupante.
- Todos los equipos eléctricos considerados inseguros o ineficientes por el electricista o la administración de FLRA deben ser retirados inmediatamente de las instalaciones.
- La seguridad tiene el derecho de inspeccionar las habitaciones compartidas en cualquier momento.

– Nota – La Asociación de Carreras de Finger Lakes, puede, a su discreción, y sin previo aviso, cancelar los privilegios de la habitación compartida de cualquier individuo por violación de las regulaciones anteriores, o cualquier otra causa considerada en su mejor interés.
