

STEWARDS CORNER 2024

Week 5/13 – 5/18

May 13, 2024 – Race 7

Stewards inquiry into the start of the race concerning the #3 “N Y Riesling” (Nazario Alvarado). After reviewing the video, the stewards determined the start was compromised and made #3 “N Y Riesling” a non-starter for betting purposes. New order of finish 4.6.1.5

Week 5/20 – 5/25

May 21, 2024 – Race 4

Stewards inquiry and jockey’s objection, by the rider of #3 “Crunch B B B” (Andre Worrie) against #1 “Gonna Be Dancing” (Heman Harkie), for possible interference in the vicinity of the ¼ pole. A second objection was also filed by #6 “Holey Matrimony” (Michael Davila, Jr) against #1 “Gonna Be Dancing’ (Heman Harkie), for possible interference in the stretch. After reviewing the video and speaking to the riders involved, the stewards determined the incidents did not affect the outcome of the race and made the race official as is. Final order of finish 1.3.6.7

May 22, 2024 – Race 8

Stewards inquiry in the stretch run, involving #5 “Joyful Departure” (Joel Cruz). After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. Final order of finish 8.5.7.4

Week 5/27 – 6/1

May 29, 2024 – Race 7

Jockey’s objection by the rider of #4 “Fighter Kite” (Carlos Camilo) against #2 “Sharpaz” (John Davila, Jr.) for possible interference in the vicinity of the 5 ½ Furlong pole. After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. Final order of finish 2.6.1.5

Week 6/3 – 6/8

June 4, 2024 – Race 4

Stewards inquiry and trainers objection, by the #2 “Big Bad Bud” (Anthony Rodriguez) against #4 “Son of Darkness” (Andre S. Worrie), for possible interference in the vicinity of the ½ mile pole. Jockeys objections were also filed by #1 “Trappe the Dream” (Kevin Navarro) and #5 “Ghost Giant” (Jacqueline Davis) both against #6 “Winning Drive” (Heman Harkie) in the vicinity of the ½ mile pole. After reviewing the video and speaking to the riders involved, the stewards determined the interference did affect the outcome of the race and disqualified #4 “Son of Darkness” from 1st position and was placed 2nd behind #2 “Big Bad Bud”. The stewards determined the second incident did not affect the outcome of the race. New order of finish 2.4.6.1

June 5, 2024 – Race 8

Stewards inquiry and jockeys objection, by the #2 “Lady Lawrence” (Keiber Coa) against #1 “Sol Emperatriz” (Michael Davila), for possible interference just after the start. The stewards inquiry also involved the start of #8 “Imalottalady” (Carlos Camilo). After reviewing the video and speaking to the riders involved, the stewards determined the interference did affect the outcome of the race and disqualified #1 “Sol Emperatriz” from 3rd position and was placed 4th behind #2 “Lady Lawrence”. The stewards determined the second incident did not affect the outcome of the race. New order of finish 4.8.2.1

Week 6/10 – 6/15

June 12, 2024 – Race 3

Stewards inquiry and jockeys objection by the #2 “Lady’s Golden Guy” (Nazario Alvarado) against #3 “Disco Deano” (Keiber Coa), for possible interference just after the start. After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. Final order of finish 5.3.2.4

June 12, 2024 – Race 7

Jockey’s objection by the rider of #2 “Mo Trump” (Anthony Rodriguez) against #4 “Newport Bridge” (Andre Worrie) in the vicinity of the 5/8th pole. After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. Final order of finish 1.5.6.4

Week 6/17 – 6/22

June 19, 2024 – Race 8

Stewards inquiry into the stretch run concerning the #1 “Nutsie” (Anthony Rodriguez) and #4 “Smooth Tales” (Jacqueline Davis). After reviewing the video and speaking to the riders involved, the stewards determined the incident did affect the outcome of the race and disqualified the #1 “Nutsie” from 1st position and was placed 2nd behind #4 “Smooth Tales”. New order of finish 4.1.7.6

Week 6/24 – 6/29

Nothing to report.

Week 7/1 – 7/6

July 1, 2024 – Race 7

Stewards inquiry and jockeys objection by the #4 “Rhymes Like Dimes” (Nazario Alvarado) against #4 “Devil Or Angel” (Keiber Coa), for possible interference at the top of the stretch. After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. Final order of finish 6.4.2.5

Week 7/8 – 7/13

July 8, 2024 – Race 3

Stewards inquiry into the start of the race, involving #4 “Styner” (Andre Worrie). After reviewing the video the stewards determined the horse caused its own issues leaving the gate and made the race official as is. Final order of finish 3.1.2.5

July 9, 2024 – Race 1

Stewards inquiry and jockey’s objection by the #5 “Dharma” (Luis Perez) against #3 “Go Ny Go” (Keiber Coa), for possible interference in the stretch. After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. Final order of finish 3.4.5.1

Week 7/15 – 7/20

July 15, 2024 – Race 1

Stewards inquiry into the start of the race, involving #5 “Archivist” (Nazario Alvarado). After reviewing the video the stewards determined the horse caused its own issues leaving the gate and made the race official as is. Final order of finish 1.3.4.7

Week 7/22 – 7/27

July 23, 2024 – Race 6

Stewards inquiry into the start of the race, involving #3 “Joyful Departure” (Joel Cruz). After reviewing the video the stewards determined the horse broke awkwardly leaving the starting gate, losing the rider, and made the race official as is. Final order of finish 5.7.9.4

Week 7/29 – 8/3

July 31, 2024 – Race 6

Stewards inquiry into the start of the race, involving #6 “Holey Matrimony” (Michael Davila, Jr.). After reviewing the video the stewards determined the horse’s start was compromised, and declared #6 “Holey Matrimony” a non-starter. Final order of finish 2.9.1.8

July 31, 2024 – Race 7

Trainer’s objection by the #5 “Royal Suspect” (Joel Cruz) against the #2 “Beta” (Luis Perez), for possible interference at the top of the stretch. After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. Final order of finish 2.3.5.6

July 31, 2024 – Race 8

Stewards inquiry and jockey’s objection by the #6 “Keigs” (Luis Perez) against #2 “B C Glory Days” (Heman Harkie) for possible interference throughout the stretch. A trainer’s objection was also filed by #6 “Keigs” (Luis Perez) against #7 “Captainofmyheart” (Jacqueline Davis) for possible interference in the stretch. After reviewing the video and speaking to the riders involved, the stewards determined the incidents did not affect the outcome and made the race official as is. Final order of finish 7.6.2.4

Week 8/5 – 8/10

August 5, 2024 – Race 4

Stewards inquiry into the start of the race, involving #2b “Crews in to Win” (Heman Harkie). After reviewing the video the stewards determined the horse stumbled leaving the starting gate, losing the rider, and made the race official as is. Final order of finish 4.7.3.1

Week 8/12 – 8/17

Nothing to report.

Week 8/19 – 8/24

August 20, 2024 – Race 9

Stewards inquiry and jockey's objection by the #1 "Shezenticing" (Luis Perez) against #5 "Lady Lawrence" (Keiber Coa) for possible interference in the stretch run. After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. Final order of finish 5.1.6.9

Week 8/26 – 8/31

August 27, 2024 – Race 5

Stewards inquiry and jockey's objection by the #6 "Rubys Mission" (Emanuel DeDiego) against #1 "Dorth's Sol Dancer" (Keiber Coa) for possible interference in the stretch run. After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. Final order of finish 1.2.4.6

Week 9/2 – 9/7

Nothing to report.

Week 9/9 – 9/14

September 9, 2024 – Race 6

Stewards inquiry and jockey's objection by the #8 "Not My Type" (Rafael Rohena Jr) against #4 "Painting Stones" (Jeremias Flores) for possible interference in the stretch. After reviewing the video and speaking to the riders involved, the stewards determined the incident did affect the outcome of the race and disqualified #4 "Painting Stones" from 3rd position and was placed 5th behind #8 "Not My Type".
New order of finish 1.7.3.8

September 9, 2024 – Race 8

Jockey's objection by the #3 "Inouaintalkintome" (Carlos Camilo) against #4 "Waitwaitdonttelleme" (Luis Perez) for possible interference in the stretch. After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. Final order of finish 5.4.3.7

Week 9/16 – 9/21

September 17, 2024 – Race 8

Stewards inquiry into an incident in the vicinity of the 5/8th pole involving #2 “B C Glory Days” (Reylu Gutierrez), #4 “Noah’s Destiny” (Jose Baez), and #5 “Peanutbuttertoast” (Heman Harkie). After reviewing the video and speaking to the riders involved, the stewards determined the incident did not warrant a disqualification and made the race official as is. Final order of finish 11.10.6.2

September 18, 2024 – Race 2

Stewards inquiry and jockey’s objection by the #7 “Last Drink” (Heman Harkie) against the #3 “G Munning” (Jacqueline Davis) and #4 “Brokenhearted” (Joel Cruz) for possible interference in the stretch run. After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. Final order of finish 4.3.7.5

September 18, 2024 – Race 3

Stewards inquiry into the stretch run, involving #4 “Love That Bird” (Keiber Coa) and #6 “Street Cop Officer” (Luis Perez). After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. Final order of finish 4.5.6.1

Week 9/23 – 9/ 29

September 23, 2024 – Race 4

Stewards inquiry and jockey’s objection by the #8 “Investment Grade” (Luis Perez) against #3 “Laughter” (Kevin Navarro) for possible interference in the stretch. After reviewing the video and speaking to the riders involved, the stewards determined the incident did affect the outcome of the race and disqualified #3 “Laughter” from 1st position and was placed 2nd behind #8 “Investment Grade”. New order of finish 3.8.2.1

Week 9/30 – 10/5

October 2, 2024 – Race 6

Trainers objection by the #2 “Pot of Gold” (John Berrios) against the #5 “Matty’s Express” (Anthony Rodriguez), for possible interference at the top of the stretch. After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. Final order of finish 3.5.2.6

Week 10/7 – 10/12

October 8, 2024 – Race 4

Stewards inquiry into the start, regarding #5 “Invaluable Will” (Joel Cruz). After reviewing the video the stewards determined the horses start was compromised, causing the rider to be unseated in the starting gate and declared #5 “Invaluable Will” a non-starter. Final order of finish 8.7.9.3

Week 10/14 – 10/19

Nothing to report.

Week 10/21 – 10/26

October 21, 2024 – Race 8

Jockey’s objection by the rider of #7 “In the Chase” (Reylu Gutierrez) against #8 “Buttah” (Lane Luzzi) for possible interference. After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. Final order of finish 4.3.2.8

October 23, 2024 – Race 8

Stewards inquiry into the start of the race, involving #1 “Wabaunsee” (Heman Harkie). After reviewing the video the stewards determined the horse caused its own issues leaving the starting gate and made the race official as is. Final order of finish 5.6.2.3

Week 10/28 – 11/2

October 28, 2024 – Race 2

Stewards inquiry into an incident involving the #1 “Widow” (Heman Harkie) being unseated in the vicinity of the 11/16^{ths} pole after clipping heels with the #2 “Bella Banker” (Rafeal Rohena, Jr). After reviewing the video the stewards disqualified #2 “Bella Banker” from 2nd position and was placed 5th. New order of finish 5.3.6.4

October 28, 2024 – Race 5

Jockey’s objection by the rider of #3 “Hineni” (Jacqueline Davis) against #4 “Dancinwithjake” (Heman Harkie) for possible interference. After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. Final order of finish 1.6.4.3

Week 11/4 – 11/9

November 6, 2024 – Race 7

Stewards inquiry into an incident involving the #3 “Wingo Starr” (Jacqueline Davis) for possible interference in the stretch. After reviewing the video and speaking to the riders involved, the stewards determined the incident did affect the outcome and disqualified #3 “Wingo Star” from 2nd position and was placed 5th behind #5 “Express Pass” (Emanuel De Diego). New order of finish 7.4.8.5

Week 11/11 – 11/16

November 12, 2024 – Race 4

Stewards inquiry into the start of the race, involving #1 “Princess Deb” (Lane Luzzi). After reviewing the video the stewards determined the horse caused its own issues leaving the starting gate and made the race official as is. Final order of finish 9.5.2.4

Week 11/18 – 11/23

Nothing to report.

Week 11/25 – 11/30

November 26, 2024 – Race 8

Stewards inquiry and jockey’s objection by the #5 “Seatiger” (JM Rohena) against #8 “Papi On Ice” (Heman Harkie) for possible interference in the stretch. After reviewing the video and speaking to the riders involved, the stewards determined the incident did affect the outcome of the race and disqualified #8 “Papi On Ice” from 4th position and was placed 5th behind #5 “Seatiger”.

New order of finish 9.3.1.5

November 27, 2024 – Race 6

Stewards inquiry into the start of the race involving #3 “Gliding Afleet” (Rafael Rohena Jr). After reviewing the video the stewards determined the horse stumbled leaving the starting gate and unseated its rider. Final order of finish 5.2.11.4
